



INFORMATION FOR GUN IMPORT FROM ANY COUNTRY OUT OF EU

You are welcome to bring your own guns and we will help you with all the paper work.

You can also use our guns if you wish it. We have several rifles available.

Documents Required:

- Contact the closest Spanish Consulate to your Residence and inform them about your hunting trip to Spain. You will have to fill an application with some information like, dates of the hunt, gun serial number, hunting locations (we will give you that information), personal data.
- Photocopy of your passport.
- Photocopy sworn translation into spanish, of your hunting license as a prove that you Hunt in your country.
- Please note that it is important to contact the Consulate at least two months before the Hunt. Otherwise you will not have enough time to do it.
See the consulate list at the end of the document.

With all this information the consulate will provide you a Certificate that allows you to use your own gun to hunt in Spain.

Once you get this Certificate you will send a copy to Trophy Trails, and so for us to start all the procedures.

It is important that you bring the original Certificate when you come to Spain.

The guns would not be at the luggage lounge with the rest of your suitcases. They will directly be sent to a special police booth.

You just have to exit and a reliable person from Trophy Trails will be outside waiting for you and will take care of all the gun paperwork.

Trophy Trails will help you again with this procedures on the departure day.

European air regulation doesn't allow to travel together ammunition with the gun. It has to be separated in a Metallic or Pvc box.

When you come to Spain there is no problem if you bring it in your luggage but once you take the airplane on your way back it has to be in a separate box.
